Motion:

1. Noting our serious reservations regarding the conduct and language of former On Dit editor Habibah Jaghoori, the SRC also acknowledges the importance of editorial independence and freedom of speech of student Journalism. The SRC also acknowledges the need for any decision of the YouX Board to comply with the Constitution in exercising its powers.

1. The SRC expresses its deep concern regarding the constitutionality of the YouX Board's removal of On Dit editor Jaghoori.
2. Noting the YouX Board and Special committee found the On Dit Editor Jaghoori did not breach the AUSM Director Obligations, the SRC is deeply concerned regarding the implications this decision has for the freedom of media and On Dit editorial content.

- The SRC fully supports the integrity of Habibah Jaghoori both personally and professionally as a student journalist and commends the amazing work she has done with student media, on dit as well as keeping student politics in check
- That the SRC condemns the removal of Habibah Jaghoori, a democratically elected student to the Adelaide University student media magazine, On Dit, and calls for the YouX and the YouX Student Media Independent Committee to immediately reinstate her.
- The SRC acknowledges that the removal of Habibah Jaghoori from On Dit is entirely dictatorial and is a direct attack on both student democracy and independent student media.
- In the interest of student democracy and transparency the SRC calls on the YouX board and the YouX Student Media Independent Committee to release a full report of the investigation, the referral process, the specific cases of the breaching of rules and resolutions and the final decision to remove Habibah Jaghoori. - Amenable
- The SRC endorses the draft statement written by past On Dit editors by signing on to the statement as the full SRC body.

- The SRC shares to its social media platforms a post of recognition, commendation and solidarity for and with Habibah Jaghoori, and also outlines the complete attack that her removal is to independent student media, journalism and democracy.
- The president of the SRC president or any equivalent SRC member writes to the YouX board and the YouX Student Media Independent Committee requesting a full report of the process of removal of Habibah Jaghoori. - Amenable
